NOTIFICATION

No. 1024-F.T. dated the 27th July, 2018.-The Governor is pleased hereby to make the following amendments in the procedure of claims in respect of the Prize-winning tickets and for incentives, notified vide this Department No.2287-F.T. dated 26th December, 2017 (hereinafter referred to as the said notification):—

Amendments

In the said notification,—

- (1) in the introductory paragraph, for the words and figures "the prize-winning tickets of Rs.10,000/- or more and for incentives of Rs.10,000/- or more", *substitute* the words and figures "the Prize-winning tickets above Rs.10,000/- and for incentives above Rs.10,000/-";
- (2) in the paragraph marked 1,—
 - (a) for the words and figures "Rs.10,000/- or more", *substitute* the words and figures "above Rs.10,000/-";
 - (b) for the words "Indemnity Bond", *substitute* the words "Affidavit duly affirmed before Notary Public";
- (3) *omit* the paragraph marked 4 relating to Indemnity Bond;
- (4) in the paragraph marked 5, for the words and figures "Rs.10,000/- or more", *substitute* the words and figures "above Rs.10,000/-";
- (5) in the paragraph marked 6, for the words "attested by the competent authority", *substitute* the words "submitted upon self-attestation by the claimant";
- (6) for Annexure II, substitute the following:—

"Annexure-II

(Format for the AFFIDAVIT)

I, _____ (Name of the Claimant), S/O, D/O, W/O _____, aged _____ years, residing at _____ (Address of the Claimant), hereby solemnly affirm –

1. That I had purchased and therefore owned the ticket no. _____ of _____ (Name & Number of the Draw), which was held on _____ (Date of the Draw). The said lottery ticket has won the _____ prize of Rs. _____ (_____ only) of the mentioned draw of West Bengal State Lottery conducted by the Directorate of State Lotteries, Government of West Bengal, 69, G.C. Avenue, Kolkata - 700013.
2. That after payment has been made to me, in the event of a genuine claim being made, by any other person, against the Government with respect to the aforesaid prize of aforesaid sum, I hereby undertake to refund to the Director of State Lotteries, Government of West Bengal the said sum mentioned at para 1 above.
3. That I hereby submit the prize-winning ticket duly signed by me on the backside for payment of the net prize amount after deduction of the Charges (if any), as mentioned on the overleaf of the ticket and Income Tax as admissible and as per conditions mentioned in the ticket. I also affirm that the ticket submitted by me is genuine.
4. That the above statements made are true to my knowledge and belief.
